Notice is hereby given that sealed bids for the above listed Contract will be received by the Atlantic County Improvement Authority on Friday, August 25, 2006 at the hour of 2:00pm, at which time bids shall be publicly opened and read in the Office of the Casino Reinvestment Development Authority, 1014 Atlantic Avenue, Atlantic City, NJ 08401.

Each bid when submitted shall be accompanied by a Bid Bond drawn to the order of the Atlantic County Improvement Authority, on the form furnished with the Bid Forms and other Contract Documents, for a sum of ten (10%) percent of the total bid amount (said Bid Bond not to exceed \$20,000.00). Each bid shall also be accompanied by such other documents and information as are required by the Bid Documents.

Bids shall be on a lump sum basis for the base contract. Unit prices shall also be listed as delineated on the Form of Proposal.

Bidders are required to comply with the laws and regulations of the State of New Jersey pertaining to construction projects, including, but not limited to the following: New Jersey Public Law 1975, c.127, "Law Against Discrimination"; New Jersey Public Law 1977. c.33, "An Act Requiring the Reporting of the Names and Addresses of Shareholders or Partners owning over Ten Percent (10%) of an Enterprise"; New Jersey Public Law 1963, c.150, "Prevailing Wage Act"; P.L. 2004, c. 57; N.J.S.A. 19:44A-20.4 et. seq., (New Jersey Local Unit "Pay to Play" Law); and all amendments thereof.
